The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of Sudhakar Rao Naik Institute of Pharmacy (D.Pharm), Pusad, for session 2018-19.

Instructions for Students

1. Ragging is strictly forbidden in or outside the campus.
2. All students shall familiarize themselves with rules/regulations/guidelines on code of conduct, anti-ragging measures and discipline of SNIOP.
3. All 'freshers' should attend counseling sessions organized for them from time to time by the college staff.
4. All 'freshers' are allotted to 'Academic Counselor/ Mentor' by name. Students may approach him/her for personal/academic counseling.
5. Any student who suffers ragging or notices occurrence of ragging shall immediately report the event to concerned authority.
6. Incidences of ragging can be reported to any member of Anti-ragging squad, Anti-ragging committee of the college or to Academic counselor/ Mentor.
7. Students may report incidence of ragging either orally or in writing. They may also report the incidence in person or by phone. Anonymity of the caller will be maintained.
8. The College Council has identified some senior students as 'Mentor'. List of these students is placed on notice board of the college. A fresher may choose any one of them as his buddy. He/she will provide emotional and peer support to the fresher in coping with institutional transition.
9. Any victim of ragging not satisfied with the action taken by the Principal may submit an appeal in writing to report the event to the local police.
